Sub: - To Notify Ahmedabad University, Navrangpura (Gujarat) under the list of Private Universities maintained by the UGC.

Sir,

With reference to Gujarat Government notification No. GH/SH/24/GPU-2009-321-Kh(1) dated 7<sup>th</sup> July, 210 on the above subject, I am directed to say that Ahmedabad University, Navrangpura (Gujarat) has been established by an Act (No. 8 of 2009) of State Legislature of Gujarat as a State Private University and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its main campus with the approval of statutory bodies / councils, wherever required.

There is no provision to affiliate Colleges/have Regional Centres and off Campus etc beyond the territorial jurisdiction of the State as per the UGC (Establishment of and Maintenance of Standards in Private University) Regulation, 2003 and the judgment of the Hon'ble Supreme Court in the case of Prof. Yashpal Vs State of Chhattisgarh.

Keeping in view of the above, Following may please be ensured:-

1. No off campus centre(s) is opened by the University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yash Pal Vs State of Chhattisgarh.
2. In case the University has already started any off campus centre outside the State, it must be closed immediately. It may also be ensured that any off campus centre within the State shall be opened only as per the provision laid down in the UGC (Establishment of and maintenance of standards in Private Universities) Regulations, 2003 and with the prior approval of UGC.
3. The University shall not have any affiliated Colleges.
4. The University has to follow UGC (Minimum standards and procedure for award of M.Phil / Ph.D degree) Regulations, 2009 & other rules & regulations issued from time to time & posted on UGC website.

The University is required to follow the UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 (copy enclosed)

The information in the prescribed format (copy enclosed) may please be sent for inspection purpose as per UGC Regulation referred to above within one month from the date of receipt of this letter.
