Dear Chairman Anubhai,,

We are delighted to welcome Ahmedabad University as our next Argosy Collaborative Faculty Exchange partner. Under this program, Olin will host two Ahmedabad faculty members, to be selected by mutual agreement, each semester for four consecutive semesters. Our partnership will begin with the Spring 2016 semester, which will run approximately mid-January to mid-May. Our fall semester extends from late August to late December. During each residency period, Argosy partner faculty will work with Olin faculty and engage in collaborative curricular creation and innovation.

Each participating Ahmedabad faculty member will shadow one Olin course during the semester. If an Ahmedabad faculty member is in residence for a second semester, teaching may include piloting of curriculum designed for use at Ahmedabad. While co-teaching we expect that the visiting faculty member will join teaching team meetings, provide some coverage during class activities, and contribute in other ways as appropriate to the faculty member's interest and disciplinary field. Specific courses will be determined by mutual agreement based on visiting faculty interest, collaborative opportunities, and excellence of the pedagogic environment, subject to Olin staffing constraints.

During their time here, the Ahmedabad faculty members will be invited and encouraged to participate in all aspects of faculty life at Olin College, and should consider themselves a part of the community during their visit. There are many "extracurricular" opportunities for faculty, especially engaging with Olin students and forging connections with faculty and staff. This includes attending open faculty meetings and participating in events like our end-of-semester EXPO and Candidates Weekend.


