Memorandum of Understanding
on Academic Cooperation between

The University of Glasgow, Scotland, UK

and

Ahmedabad University, Gujarat, India

The Parties;

The University Court of the University of Glasgow, incorporated under the Universities (Scotland) Act 1889 and having its principal office at University Avenue, Glasgow G12 8QQ, Scotland, UK, a registered Scottish charity (Charity Number SC004401, Charity Name "University of Glasgow Court", (hereinafter "UoG"); and **Ahmedabad University**, AES Bungalow # 2, Commerce Six Roads, Navrangpura, Ahmedabad – 380009 Gujarat, INDIA, (hereinafter "AU") recognising the benefits to their respective universities from the establishment of international links, conclude this Memorandum of Understanding (hereinafter: "MoU").

1. The purpose of this MoU is to develop academic and educational co-operation and to promote mutual understanding between the two Parties.
2. Each Party agrees to explore the potential for the development of the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.
 - 2.1) Receive visiting scholars
 - 2.2) Articulation arrangements for MSc degrees (Management)
 - 2.3) Study Abroad arrangements
 - 2.4) Promoting collaboration in fields of mutual interest
 - 2.5) Promoting other academic co-operation as mutually agreed
3. The development and implementation of specific activities based on this MoU will be separately negotiated and agreed between the Parties and will be subject to a separate written agreement. Each Party agrees to carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.
4. It is understood that the implementation of any of the types of co-operation stated in Clause 2 shall depend upon the availability of resources and financial support of the Parties concerned.

5. Both Parties agree that prior written approval is required before using the other Party's name, logo, or other Intellectual Property rights in any advertising or associated publicity.
6. Should the collaborative research activities under this MoU result in any potential for intellectual property, each Party shall seek an equitable and fair agreement as to ownership and other property interests that may arise.
7. This MoU may only be amended or modified by a written agreement signed by the representatives of each Party.
8. This MoU is valid for a period of five years from the date of signing by the authorised signatories of each Party. Each Party shall review the status of the MoU at least three months before the end of the five-year period to determine whether it wishes the MoU to continue and, if so, any modifications that might be necessary. The period of validity of this MoU may only be extended by the mutual written consent of both Parties.
9. This MoU may, at any time during its period of validity, be terminated by one of the Parties upon prior notice to the other in writing not later than six months before the termination date.
10. The Parties may disclose certain confidential information to the other in relation to any future proposal made under this MoU. Each Party therefore agrees that the contents of this MoU and the negotiations in relation to any future proposal remain strictly confidential and each Party hereby undertakes not to disclose the same to any third Party, save for its professional advisers, without the prior written consent of the other Party except where such disclosure is required by law (including, without limitation, under applicable freedom of information legislation).
11. This MoU shall be governed by and construed in accordance with Scots law save that issues relating to the validity or enforcement of any Intellectual Property Rights shall be governed by the law of the country of registration (if any) of those rights. The Parties hereby submit to the exclusive jurisdiction of the courts of Scotland.
