Academic Research, Teaching and Capacity Development Cooperation

This **Memorandum of Understanding** is intended to promote international cooperation between Amrut Mody School of Management of the Ahmedabad University and the Rady School of Management of the University of California San Diego (UCSD). The purpose of this agreement is to develop academic and educational cooperation across various of areas, between the two schools of UCSD and Ahmedabad University, and to cooperate in their mutual developmental interest for a range of academic programs and activities. The areas of cooperation may include, subject to mutual consent, any desirable and feasible activity for joint R&D and education capacity building, such as:

- a. Jointly conducting executive education programs in various sectors
- b. Jointly conducting research and development projects
- c. Exchange of researchers, faculty and students under various mobility programs
- d. Exchange of information, teaching materials, technological and scientific publications
- e. Facilitating opportunities for professors and researchers to visit and deliver lectures and workshops at each other's university
- f. Jointly search for opportunities to collaborate in the future
- g. Organization of lectures, symposia, international meetings, conferences and workshops

The collaborating parties will enter into specific written agreements under the overarching aegis of this Memorandum of Understanding to clarify and define the specific nature, scope of geographies to operate, extent and terms of operation for the proposed collaborations, including financial and operational arrangements and ownership of intellectual property. Prior to entering into any such agreements, these agreements will require the approval of appropriate officers from each institution.

This Memorandum of Understanding will become effective immediately after signature by the representatives of UCSD and AHMEDABAD UNIVERSITY, and will be valid for a period of **five** years and may be renewed thereafter after due review process. This cooperation agreement may be amended in future by a written agreement signed by the appropriate representatives of both universities. In the event of any unforeseen incident during collaborative activities in either country both universities agree to negotiate a mutually acceptable solution. This agreement may, at any time during its period of validity, be terminated by either party upon prior notice to the other in writing not later than three months before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.



