**Agreement of Cultural, Educational and Scientific Cooperation  
between the Ahmedabad University, India and the University of Ferrara, Italy**

In accordance with a mutual desire to promote further cooperation between India and Italy, the Ahmedabad University and the University of Ferrara join in the following agreement on cultural, educational and scientific cooperation.

Both Organisations will encourage direct contact and cooperation between their members, departments, institutes and other research centres subject to the provisions of this Agreement, and will act as coordinators of contacts with other Institutions as appropriate.

**The Ahmedabad University and the University of Ferrara shall cooperate in fields of research to be agreed upon.**

Both Organisations agree to the following general forms of cooperation:

- Exchange of invitations to scholars-teachers for lectures, talks, and sharing of experience.
- Exchange of invitations to scholars-teachers to participate in conferences, colloquia, symposia.
- Exchange of information in fields of interest to both Institutions.
- Exchange of faculty members, graduate students for study and research.
- Joint research activities.

Themes of joint activities and the conditions for utilizing the results achieved and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific case.

Both Organisations understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.

This Agreement shall become effective after its signature by both parties, on the day of the last signature.

The Agreement shall be in force for a period of five years; thereafter, it may be renewed by mutual agreement. Either Organisation has the right to terminate this Agreement without cause, by providing notice in writing, a minimum of six months in advance.

This Agreement is drawn up in the English and Italian languages. The parties acknowledge that only the English version of the agreement has legal value.

Ahmedabad University con sede ad Ahmedabad, India  
e l'Università degli Studi di Ferrara, con sede in Ferrara, Italia**

L'Ahmedabad University e l'Università di Ferrara, visto il comune interesse a promuovere una maggiore collaborazione fra India ed Italia, sottoscrivono il seguente accordo di cooperazione culturale, didattica e scientifica.

In base al presente accordo entrambe le istituzioni promuoveranno la collaborazione ed i contatti diretti fra i membri delle rispettive facoltà, dipartimenti, istituti ed altri centri di ricerca e si incaricheranno di coordinare contatti con altre istituzioni di interesse.

L'Ahmedabad University e l'Università di Ferrara coopereranno nei settori di insegnamento e di ricerca che saranno definiti congiuntamente.

Le due istituzioni concordano le seguenti tipologie di cooperazione:

- Scambio di inviti a studiosi per lezioni, seminari, nonché per la condivisione di esperienze.
- Scambi di inviti a studiosi per la partecipazione a conferenze, colloqui, simposi.
- Scambio di informazioni nei campi di interesse comune delle due istituzioni.
- Scambio di studenti neo-laureati, docenti, ricercatori per attività di studio e ricerca.
- Attività di ricerca congiunte.

Le tematiche oggetto di attività congiunte, le modalità di utilizzo dei risultati raggiunti e gli accordi per specifiche visite, scambi o altre forme di collaborazione saranno negoziati caso per caso.

Le due istituzioni definiranno gli aspetti finanziari in relazione alla disponibilità di fondi di bilancio.

Il presente accordo entra in vigore a seguito della sua sottoscrizione da parte dei legali rappresentanti delle due istituzioni, nella data dell'ultima firma.

L'accordo ha una durata di 5 anni; lo stesso potrà essere rinnovato previo accordo fra le parti. L'accordo può essere disdetto da ciascuna istituzione, con un preavviso scritto di almeno 6 mesi.

Il presente accordo è redatto in lingua inglese e italiana. Le parti concordano che la versione avente valore legale è quella inglese.
